**ORDER:**

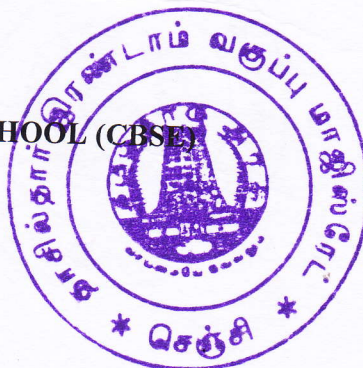
