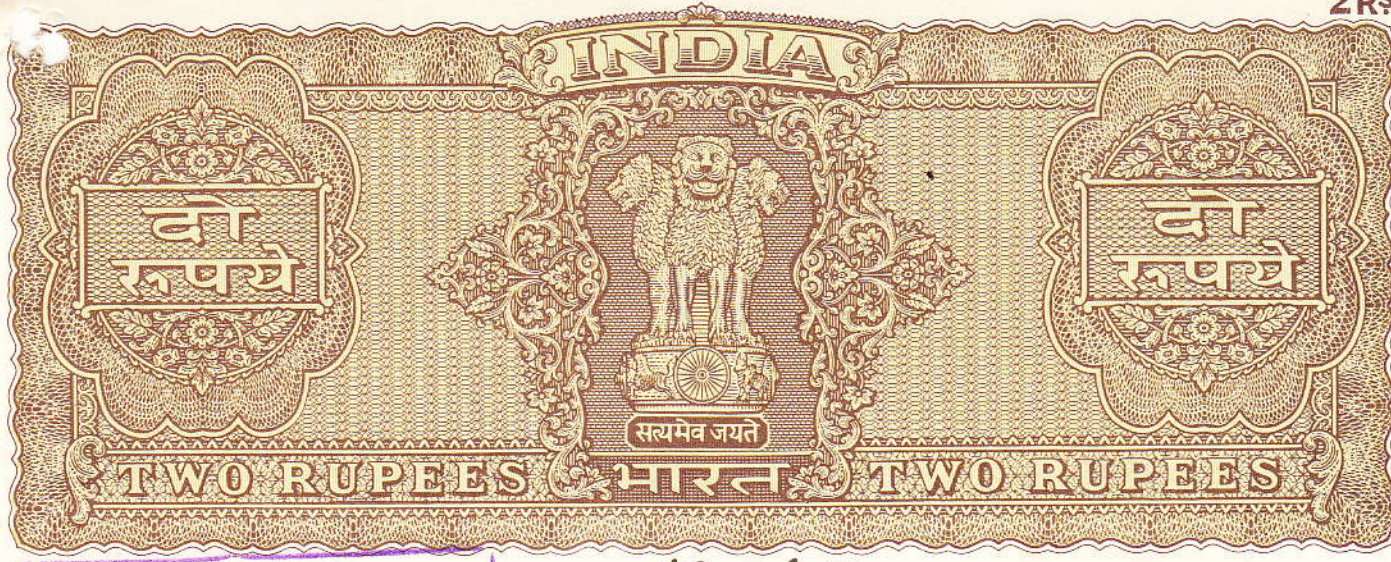

(r) To aid and assist the advancement of any other object of general public utility.

(s) To do all such things as may be necessary or conducive for the advancement of the objects above mentioned.

b) The number of TRUSTEES shall not be less than SEVEN and shall not exceed FIFTEEN.

c) The number of TRUSTEES may be altered according to the decision of the Board of Trustee, subject to clause (b) supra.

d) Vacancies caused by removal, death, retirement, resignation or by any other incapacity or reason in the Board of Trustees shall be filled by co-option by remaining trustees.

b) To open one or more bank accounts in the name and for the Trust any where in India and the Secretary and the Treasurer shall be authorised to have the power to operate such Bank accounts jointly.

c) To invest funds of the Trust in any movable or immovable property in any part of the country (India) and further will have the power to sell or vary such investments according to their discretion from time to time.

d) The Managing Trustee shall maintain or cause to be maintained proper books of account of the monies, properties, income and expenditure of the Trust which shall be audited every year by a Chartered Accountant duly appointed for the purpose.

sell or lease out for a period exceeding one year, or otherwise alienate the immovable properties, if any other trust; unless and until necessity or occasion compells such a sale, transfer or encumbrance, or other alienation of the immovable properties. If any such event, the Managing Trustees shall be competent to sell, lease, encumber or otherwise alienate the properties of the trust, after due authorisation by the Board of Trustees.

f) To do all such acts and things as are necessary for the control and management of the affairs of the trust and for purposes of attainment of the objects of the Trust.

g) To raise such loan or loans for the benefit of the Trust and to sign such promissory notes, bills of exchange, hundies or any other financial documents that may be necessary for and on behalf of the trust.

h) To settle, compromise or compound all or any of the debts, claims, outstanding amounts, disputes, demands, actions, suits, and proceedings, whatsoever by or against in any manner related to the Trust or refer the same to Arbitration.

i) To lend or invest the surplus funds of the Trust in such manner as may be decided by the Board of Trustees.

j) To incur all such expenses as are necessary for the execution of the Trust and powers under these presents.

k) To raise donations or accept gifts or contributions in cash or in kind.

l) To appoint auditors to audit the accounts of the Trust.

m) To appoint legal advisers for the Trust.

n) To appoint such staff as may be necessary for the due administration of the Trust on such remuneration, commission or salary as the Trustees may think proper and suspend, remove or replace them whenever necessary.

q) To make, alter, rescind any rules or regulations in regard to the conduct of affairs in respect of which any power or duty is vested in them for the convenient and effective management and administration of the Trust.

6. POWER TO CO-OPT :- The Trustees shall have the power to co-opt additional Trustees or to fill-up any existing vacancy in the Board of Trustees, so however, that the total number of Trustees shall not be below or exceed the number fixed in clause 4(b) supra.

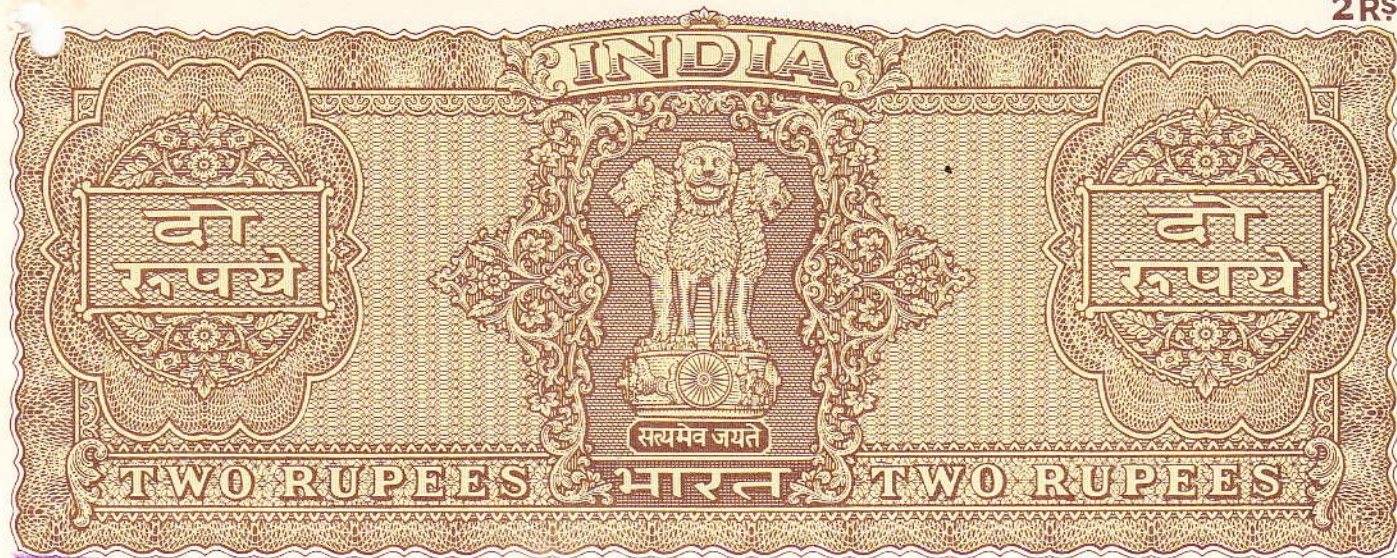
7. VACANCIES OCCURRING IN THE OFFICE OF THE TRUSTEES:-

8. VACANCY NOT TO INVALIDATE THE PROCEEDING :-

Any vacancy in the Board of Trustees and/or any illegality in appointment of TRUSTEES, or their Proceedings shall not invalidate any prior act or decision of the Board of Trustees.

9. ADMINISTRATION :- The Board of Trustees shall have full power and authority to administer the trust, its properties and affairs and to do all acts, deeds and things which are calculated to fulfil the performances for which the TRUST is established. The Board of Trustees shall act through the Managing Trustee.

10. APPOINTMENT OF MANAGING TRUSTEE :- The first Managing Trustee shall be Thiru P.BABU, who shall hold office for a period of 5 years. Thereafter a Managing Trustee shall be elected from amongst the Board of Trustees to hold office for a period not exceeding 5 years.

11. PROCEEDINGS OF THE TRUSTEES :- The Board of Trustees may meet as often as may be necessary for the efficient conduct of the Trust. The TRUSTEES may take decisions on any matter either at their meetings or by circulation of resolutions on papers. If any of the Trustees are absent in 3 consecutive Board Meetings without a prior Leave of Absence sanctioned by the Board, he shall be deemed to have vacated his office.

12. QUORUM :- The Minimum number of TRUSTEES to be present for conducting a Meeting of the Board of Trustees shall be 3 or 1/3rd of the total number of Trustees whichever is less.

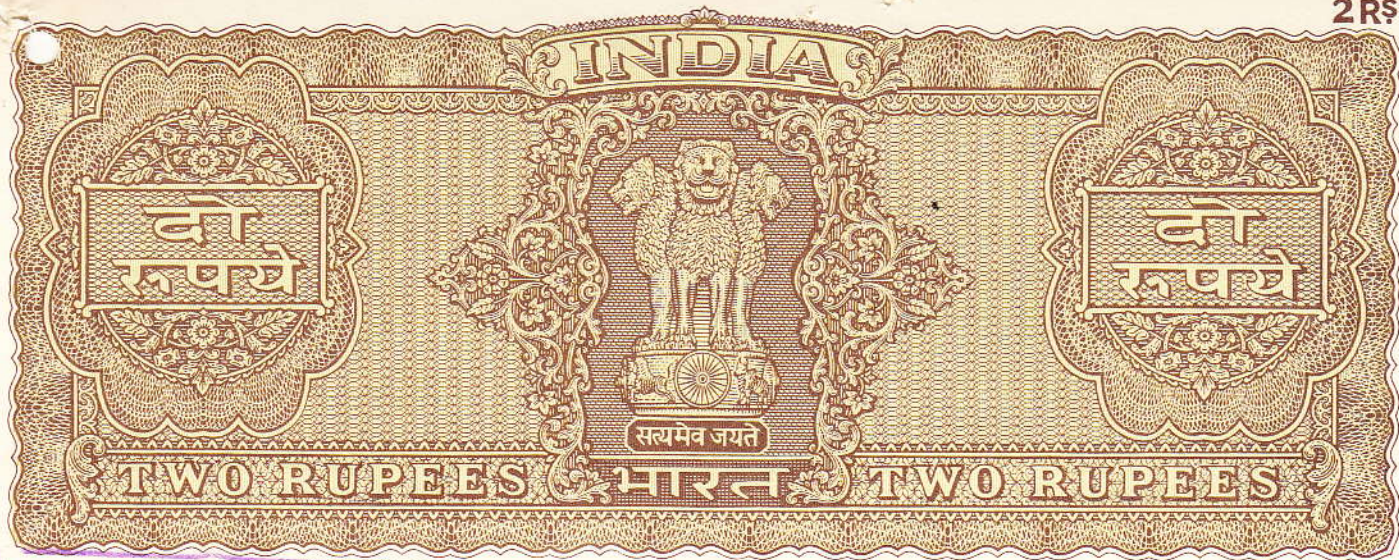

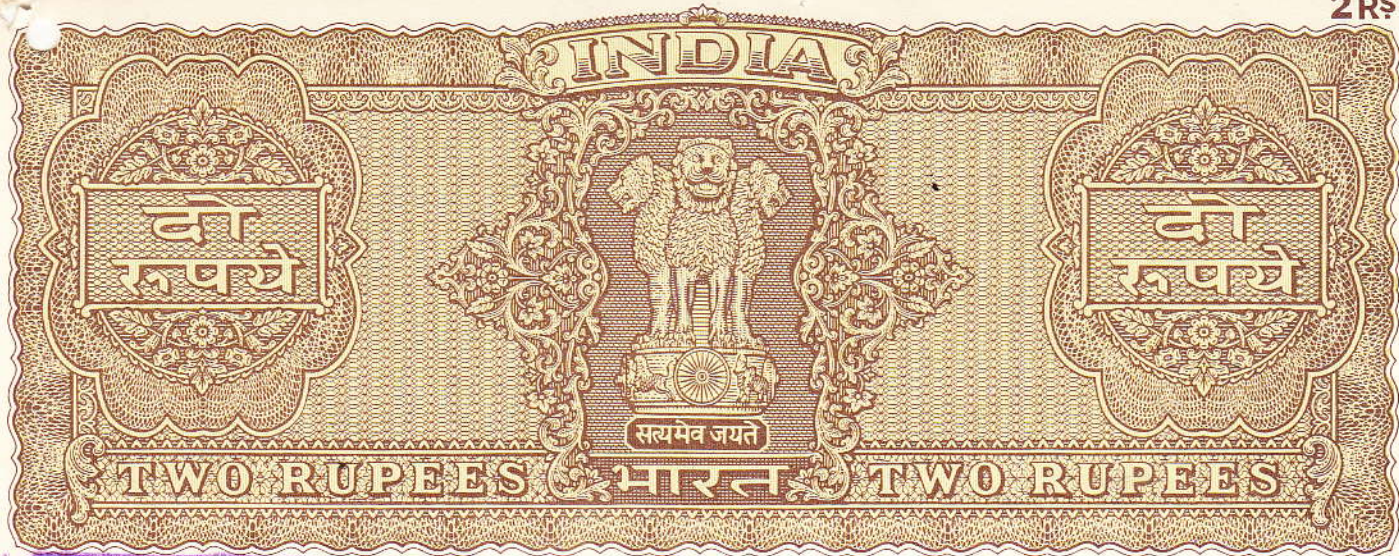

15. NET INCOME OF THE TRUST :- The TRUSTEES shall invest and recover the income of the TRUST FUND and shall provide for all costs, charges, incidental expenses, including Insurance premium expenses of ordinary repairs, etc., and all other outgoing and expenses for the management and administration of the Trust.

16. CREATION OF RESERVES :- The TRUSTEES shall set apart and credit to the depreciation, sinking or other fund, such percentage of, or portion, or whole of the income of the Trust Fund as may from time to time be determined by the TRUSTEES. However, as and when the balance standing to the credit such fund exceeds the minimum amount which, the Trustees may from time to time consider sufficient, it shall be lawful for the Trustees to transfer such surplus amount to the General Trust Fund and apply it in the same manner as the Net Income or the Trust Fund.

17. APPLICATION OF INCOME AND TRUST FUND :- The Trustees shall, after providing for the aforesaid payments and disbursement and after setting apart any sum for Sinking Fund, Reserves etc. apply and utilise the Net Income or the Corpus of the Trust, or the Trust Fund for the fulfilment of all or any of the Public Charitable purpose or objects of General public utility referred to in para 2 Supra by such ways and means as the Trustees may from time to time in their absolute and unfettered discretion determine.

18. TRUSTEES AND THEIR RELATIVES NOT TO BE BENEFIT :-

19. NO REMUNERATION TO THE TRUSTEES :- The Trustees shall not be entitled to draw any remuneration from the TRUST. The Trustees are not entitled to any profit, interest or dividend in the income of the Trust.

20. LIABILITY OF TRUSTEE OR TRUSTEES :- In the professed execution of the Trust and powers conferred, no Trustee shall be liable for any loss to the Trust properties arising by reason of improper investment made in good faith or for the negligence or fraud of any agent or employee, although the employment of such agent shall not strictly be necessary or expedient or by reason of any mistake or omission made in good faith by the TRUSTEES or by reason of any other matter or thing except wilful or deliberate fraud on the part of the TRUSTEES, who alone may be subject to be made so liable.

25. NO CASTE, CREED OR COMMUNITY :- The objects and benefits of the Trust shall be available to all irrespective of Caste, Creed or Community.

26. AMENDMENTS :- No amendments shall be effected without the consent of the Commissioner of Income Tax.
